1. Constitution

組成

1.1 The Committee is established pursuant to a resolution passed by the Board dated 26 September 2018.

本委員會是按本公司董事會日期為 2018 年 9 月 26 日通過的決議成立的。

2. Membership

成員

2.1 Members of the Committee shall be appointed by the Board from amongst the non-executive directors only of the Company and shall consist of not less than three members, a majority of whom should be independent non-executive directors. At least one member is an independent non-executive director with appropriate professional qualifications or accounting or related financial management expertise as required in rule 5.05(2) of the Rules Governing the Listing of Securities on the GEM of The Stock Exchange of Hong Kong Limited (the “GEM Listing Rules”).

委員會由董事會從其非執行董事中委任組成，委員會人數最少三名，大部分委員應為獨立非執行董事，其中至少一名須按照香港聯合交易所有限公司 GEM 證券上市規則(「GEM 上市規則」)第 5.05(2) 條具備適當專業資格或會計或相關財務管理知識。

- 2.2 The chairman of the Committee shall be appointed by the Board and shall be an independent non-executive director. 委員會主席由董事會委任及必須是獨立非執行董事。
- 2.3 A former partner of the Company's existing auditing firm shall be prohibited from acting as a member of the Committee for a period of at least two years from the date of his ceasing: 現時負責審核本公司帳目的核數公司的前任合夥人在以下日期(以日期較後者為準)起計至少兩年內，不得擔任委員會的成員：
- (a) to be a partner of the firm; or (a) 他終止成為該公司合夥人的日期；或
- (b) to have any financial interest in the firm, whichever is later. (b) 他不再享有該公司財務利益的日期。
- 2.4 The Committee shall officially appoint a secretary of the Committee. 委員會應正式委任會議秘書。
- 2.5 The appointment of the members or secretary of the Committee may be revoked, or additional members may be appointed to the Committee by resolution passed by the Board. 經董事會通過決議，方可委任額外的委員會的成員、更替或罷免委員會的成員或秘書。

3. Proceedings of the Committee

會議程序

3.1 *Notice:*

會議通知：

- (a) Unless otherwise agreed by all the Committee members (either orally or in writing), a meeting shall be called by giving at least seven days' notice. (a) 除非委員會全體成員(口頭或書面)同意，委員會的會議通知期，不應少於七天。

- (b) A Committee member may and, on the request of a Committee member, the secretary to the Committee shall, at any time summon a Committee meeting. Notice shall be given to each Committee member in person orally or in writing or by telephone or by email or by facsimile transmission at the telephone or facsimile or address or email address from time to time notified to the secretary by such Committee member or in such other manner as the Committee members may from time to time determine.

- (c) Any notice given orally shall be confirmed in writing as soon as practicable and before the meeting.

- (d) Notice of meeting shall state the purpose, time and place of the meeting and shall be accompanied by an agenda together with other documents which may be required to be considered by the members of the Committee for the purposes of the meeting. In respect of regular meetings of the Committee to be held as mentioned in clause 3.4 below, and so far as practicable for all other meetings of the Committee, the

agenda and accompanying papers shall be sent in full to all the members of the Committee in a timely manner and at least 3 days before the intended date of the meeting of the Committee (or such other period as all the Committee members may agree).

3.2 **Quorum:** The quorum of the Committee meeting shall be two members of the Committee.

3.3 **Attendance:** The finance director, the head of internal audit (or any officer(s) assuming the relevant functions but having a different designation) and a representative of the external auditors shall normally attend meetings. Other Board members shall also have the right of attendance. However, at least twice a year the Committee shall meet with the external auditors without executive Board members present.

- 3.4 **Frequency:** Meetings shall be held at least twice annually or more frequently if circumstances require and with unanimous written consent to consider the budget, revised budget and, if published for publication, quarterly report prepared by the Board. The external auditors may request the chairman of the Committee to convene a meeting, if they consider that one is necessary.

- 4. Written resolutions**

- 4.1 Written resolutions may be passed by all Committee members in writing.
- 委員會成員可以以書面決議的方式通過任何決議，惟有關書面決議必須由所有委員會成員簽字。
- 5. Alternate Committee members**

- 5.1 A Committee member may not appoint any alternate.
- 委員會成員不能委任代表。
- 6. Authority of the Audit Committee**
- 審核委員會的權力**
- 6.1 The Committee may exercise the following powers:
- 委員會可以行使以下權力：
- (a) to seek any information it requires from any employee of the Company and its subsidiaries (together, the “Group”) and any professional advisers (including auditors), to require any of them to prepare and submit reports and to attend Committee meetings and to supply information and address the questions raised by the Committee;

- (g) to request the Board to convene a shareholders' meeting (if necessary) for purposes of revoking the appointment of any director and to dismiss any employees if there is evidence showing that the relevant director and/or employee has failed to discharge his duties properly;
- (g) 在有證據顯示本集團董事及其他僱員失職時，要求董事會召開股東大會(如有需要)罷免有關人員的職務；
- (h) to request the Board to take all necessary actions, including convening an extraordinary general meeting, to replace and dismiss the auditors of the Group;
- (h) 要求董事會採取任何必要行為，包括召開特別股東大會，更替及罷免本集團的核數師；
- (i) to obtain outside legal or other independent professional advice at the cost of the Company on any matters within these terms of reference as it considers necessary and to secure the attendance of outsiders with relevant experience and expertise, if it considers this necessary;
- (i) 如委員會覺得有需要，可就涉及本職權範圍的事宜向有相關經驗及專業才能的獨立第三方尋求獨立法律及其他專業意見並由本公司負責有關費用；及
- (j) to commission reports or surveys as are necessary to assist in the performance of its duties at the cost of the Company;
- (j) 如委員會覺得有需要，可委托製作報告或進行調查以協助履行其職務並由本公司負責有關費用；
- (k) to have access to sufficient resources in order to perform its duties;
- (k) 可取得足夠資源以履行其職務；

- (l) where there is any disagreement between the Committee and the Board on the selection, appointment, resignation or dismissal of the external auditors which cannot be resolved, to report its own recommendation on such matters to the shareholders;
- (m) to review annually these terms of reference and their effectiveness in the discharge of its duties and to make recommendation to the Board any changes it considers necessary; and
- (n) to exercise such powers as the Committee may consider necessary and expedient so that their duties under section 7 below can be properly discharged.
- 6.2 The Committee should be provided with sufficient resources to perform its duties.

7. Duties

7.1 The duties of the Committee shall be:

Relationship with the Company's auditors

- (a) to be primarily responsible for making recommendation to the Board on the appointment, reappointment and removal of the external auditor, and to approve the remuneration and terms of engagement of the external auditor, and any questions of its resignation or dismissal;
- (a) 主要負責就外聘核數師的委任、重新委任及罷免向董事會提供建議，批准外聘核數師的薪酬及聘用條款、及處理任何有關該核數師辭職或辭退該核數師的問題；
- (b) to review and monitor the external auditor's independence and objectivity and the effectiveness of the audit process in accordance with applicable standards;
- (b) 按適用的標準檢討及監察外聘核數師是否獨立客觀及核數程序是否有效；
- (c) to discuss with the auditors the nature and scope of the audit and reporting obligations before the audit commences;
- (c) 於核數工作開始前先與核數師討論核數性質及範疇及有關申報責任；

- (d) to develop and implement policy on engaging of an external auditor to supply non-audit services. For this purpose, “external auditor” includes any entity that is under common control, ownership or management with the audit firm or any entity that a reasonable and informed third party knowing all relevant information would reasonably conclude to be part of the audit firm nationally or internationally. The Committee should report to the Board, identifying and making recommendations on any matters where action or improvement is needed;

Review of the Company’s financial information

- (e) to monitor the integrity of the Company’s financial statements and annual report and accounts, half-year report and, if prepared for publication, quarterly reports, and to review significant financial reporting judgements contained in them;

- (f) in reviewing these reports mentioned in paragraph (e) before submission to the Board, focusing particularly on:

8.3 The secretary of the Committee shall keep record of all meetings of the Committee held during each financial year of the Company and records of individual attendance of members of the Committee, on a named basis, at meetings held during that financial year.

9. Continuing application of the articles of association of the Company

本公司組織章程的持續適用

9.1 The articles of association of the Company regulating the meetings and proceedings of the directors so far as the same are applicable and are not replaced by the provisions in these terms of reference shall apply to the meetings and proceedings of the Committee.

10. Powers of the Board

董事會權力

10.1 The Board may, subject to compliance with the articles of association of the Company and the GEM Listing Rules, amend, supplement and revoke these terms of reference and any resolution passed by the Committee provided that no amendments to and revocation of these terms of reference and the resolutions passed by the Committee shall invalidate any prior act and resolution of the Committee which would have been valid if such terms of reference or resolution had not been amended or revoked.

本職權範圍所有規則及委員會通過的決議，可以由董事會在不違反公司章程及GEM上市規則的前提下，隨時修訂、補充及廢除，惟有關修訂、補充及廢除，並不影響任何在有關行動作出前，委員會已經通過的決議或已採取的行動的有效性。
