SUMMARY

Offer Price and Net Proceeds from the Share Offer

- The Offer Price has been determined at HK\$0.30 per Offer Share (excluding brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.30 per Offer Share and 187,500,000 Shares offered by the Company, the net proceeds from the Share Offer to be received by the Company, after deducting the underwriting fees and commission and estimated expenses paid and payable by the Company in relation to the Share Offer, are estimated to be approximately HK\$26.6 million. The Company intends to apply such net proceeds in the manner set out in the paragraph headed “Net proceeds from the Share Offer” below in this announcement and the section headed “Future plans and use of proceeds” in the Prospectus.

The Public Offer

- The Public Offer Shares initially offered under the Public Offer have been significantly over-subscribed. A total of 18,432 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and through the **HK eIPO White Form Service (www.hkeipo.hk)** for a total of 1,945,080,000 Public Offer Shares, representing approximately 103.74 times of the total number of 18,750,000 Public Offer Shares initially available for subscription under the Public Offer.

The Placing

- The Placing Shares initially offered under the Placing have been slightly undersubscribed, representing approximately 0.95 times of the 168,750,000 Placing Shares initially available for subscription under the Placing. As the Public Offer Shares are over-subscribed, the reallocation procedures as described in the section headed “Structure and conditions of the Share Offer — Re-allocation between the Placing and the Public Offer” in the Prospectus have been applied. The Sole Bookrunner has exercised its right to re-allocate 18,750,000 Offer Shares initially offered under the Placing to satisfy excess demand under the Public Offer.
